THIS SESSION OF THE EXECUTIVE BOARD UNDERSCORES THE IMPORTANCE THAT MEMBER STATES ATTACH TO ENSURING AN EFFICIENT AND SUCCESSFUL ORGANIZATION ABLE TO MEET ITS RESPONSIBILITIES; PROVIDE CLEAR GUIDANCE TO MEMBER STATES IN IMPLEMENTATION OF URBAN POLICIES AND HUMAN SETTLEMENTS AND SUSTAINABLE DEVELOPMENT GOAL 11 ENSURING THAT "NO ONE IS LEFT BEHIND."

I NOTE WITH CONCERN THAT THE VOLUNTARY CONTRIBUTIONS TO UN-HABITAT HAVE BEEN BELOW PAR, MAKING IT DIFFICULT FOR THE ORGANIZATION TO EFFECTIVELY DELIVER ON ITS NORMATIVE WORK. I URGE MEMBER STATES TO PROVIDE THE MUCH NEEDED FINANCIAL SUPPORT ESPECIALLY FOR THE FOUNDATION NON EARMARKED FUNDS.

SINCE OUR LAST EXECUTIVE BOARD MEETING WE HAVE ACCELERATED OUR EFFORTS TO MEET SDG 11 AT THE RECENT MEETINGS NAMELY:THE HIGH LEVEL MEETING ON THE NEW URBAN AGENDA, THE WORLD URBAN FORUM, AFRI-CITIES WHERE WE DISCUSSED THE ROLE OF INTERMEDIARY CITIES AND AT THE UNITED NATIONS GENERAL ASSEMBLY WHERE MEMBER STATES FINALIZED A RESOLUTION ON STRENGTHENING THE UNITED NATIONS HUMAN SETTLEMENTS PROGRAMME AND THE NEW URBAN AGENDA AND FINALLY THE JUST CONCLUDED COP 27 WHICH EMPHASIZED CLIMATE CHANGE IN OUR URBAN AREAS.

THESE EVENTS HAVE BEEN TIMELY AND PROVIDE FRESH IMPETUS TO FAST TRACKING OUR COMMITMENTS TO URBANIZATION AND HUMAN SETTLEMENTS. WE LOOK TO THE 2<sup>ND</sup> UN HABITAT ASSEMBLY IN JUNE 2023 TO FURTHER REDEFINE NEW DIRECTION CENTRAL TO URBANIZATION AND HUMAN SETTLEMENTS.

IN LINE WITH THE ASPIRATIONS OF THE ABOVE GLOBAL AGENDAS, THE GOVERNMENT OF KENYA HAS PRIORITIZED AFFORDABLE HOUSING AS ONE OF ITS KEY AGENDAS. IT TARGETS TO DELIVER 250,000 LOW-COST HOUSING UNITS ANNUALLY, WITH AN EMPHASIS ON SLUM UPGRADING AND PREVENTION AND INCREASING SOCIAL HOUSING. THE INTERVENTIONS IN THE HOUSING SECTOR INCLUDE INNOVATIVE SOLUTIONS IN THE DEMAND AND SUPPLY SIDES OF HOUSING WHICH ENTAIL MOBILIZATION OF AFFORDABLE HOUSING FINANCE; LAND IDENTIFICATION AND REGISTRATION AND REVIEW OF LEGISLATION TO HASTEN THE DELIVERY OF HOUSING.

WITH REGARD TO SUSTAINABLE URBAN DEVELOPMENT, THE GOVERNMENT IS IMPLEMENTING THE KENYA URBAN SUPPORT PROGRAM II (KUSP II), WHICH COVERS 59 MUNICIPALITIES WITHIN 45 COUNTIES. WE ARE ALSO IMPLEMENTING THE KENYA URBAN MOBILITY IMPROVEMENT PROJECT WHICH AIMS AT IMPROVING URBAN MOBILITY SERVICES IN KENYA WITH RESILIENT AND GREEN TRANSPORT INFRASTRUCTURE DEVELOPMENT FOR ADVANCING ECONOMIC AND SOCIAL DEVELOPMENT.
